The Lisle Partners for Parks Foundation is proud to sponsor the Lisle Park District Financial Assistance Program. Since its inception in 1999, the Lisle Partners for Parks Foundation, a 501 (c)(3) organization, has awarded scholarship assistance to many children, teens and adults who otherwise did not have the means to participate in recreation activities.

Recreation has been proven to promote physical, mental and social well-being. The Lisle Partners for Parks Foundation makes the benefits of recreation programs available to qualifying, low-income families throughout the greater Lisle Community. Our goal is for no child or adult to be left out of any program the Lisle Park District offers because of limited income. The Lisle Partners for Parks Foundation annually sets aside \$12,000 for financial assistance and you can make a difference by donating any amount to this program which will directly support recreation scholarships for people in our community such as:

- **Family Season Pool Pass to Sea Lion Aquatic Park - (\$120-\$240 for a family of 1-5)**
- **Camp Summer Quest - (1 child - \$1,470 for all sessions)**
- **No Name Teen Camp - (1 child - \$1,760 for all sessions)**
- **Preschool - (1 child - \$110-\$190 per month)**
- **Swim Lessons - (1 child - \$35-\$44 per session)**
- **Senior Programs & Trips - (1 senior \$5-\$350 per program/trip)**

This is only a sampling of some of the programs the foundation has supported. All park district programs are eligible for financial assistance.
